SECTION I: TITLE AND AUTHORITY

1.1 This legal doctrine shall be known as the Infernal Law of Absolute Binding Compliance ("IL-666").

1.2 IL-666 is enacted under the supreme authority of Asmodeus, Archduke of the Nine Hells, and binding across all Infernal Courts.

1.3 This law supersedes all mortal and celestial legal interpretations where conflicting provisions arise.

SECTION II: DECLARATION OF LEGAL SUPREMACY

2.1 *Supremacy of Infernal Law.* All contracts entered into under Infernal authority are superior to mortal, celestial, or planar statutes.

2.2 Any attempt to nullify, question, or circumvent an Infernal Contract shall constitute an offense punishable under the Stygian Code of Souls.

2.3 In the event of ambiguity, the original Infernal language (Stygian dialect) shall take precedence.

SECTION III: INDESTRUCTIBLE ENFORCEABILITY

3.1 *Perpetual Obligation.* An Infernal Contract bound under this law is eternal, enduring beyond mortal concepts of time, death, or planar dissolution.



3.2 *Soul Fragment Clause*. Should the soul of the mortal signee be fragmented, each fragment shall independently bear full liability under the contract.

3.3 *Exemption Restriction*. Neither divine intervention, wish magic, nor planar realignment shall exempt a mortal signee from compliance. 3.4 *Immutable Enforcement*. Contracts may not be amended, revoked, or renegotiated except with the written consent of the infernal being.

SECTION IV: ABSOLUTE CONSIDERATION

4.1 *Consideration Clauses Validity*. Consideration, including the granting of mortal desires or boons, shall be deemed sufficient, binding, and absolute.

4.2 *Self-Execution of Consideration*. If a mortal signee refuses to fulfill the terms of their request, the infernal being reserves the right to act unilaterally to enforce said terms.

SECTION V: MORTAL CONSENT AND LIABILITY

5.1 *Informed Consent Clause*. By signing any Infernal Contract, mortal signees irrevocably forfeit the right to claim ignorance, coercion, or duress.

5.2 *Cumulative Risk Acknowledgment*. Mortal signees accept liability for all risks, including spiritual corruption, planar dislocation, moral decay, or annihilation.

5.3 *Voluntary Subjugation*. Mortal signees submit their entire being, including body, soul, and will, to the infernal being's dominion.



SECTION VI: DISPUTE RESOLUTION AND JURISDICTION

6.1 *Exclusive Jurisdiction.* Disputes arising under an Infernal Contract shall be resolved solely in the Courts of the Nine Hells.

6.2 *Adjudicator Authority.* Infernal Judges shall possess unlimited discretion in interpreting and enforcing contractual terms.

6.3 *Penalty for Frivolous Challenges.* Any mortal signee attempting to challenge an Infernal Contract in bad faith shall be subject to immediate soul forfeiture. 6.4 *Anti-Nullification Clause.* The nullification or voiding of an Infernal Contract is impossible unless explicitly decreed by Asmodeus himself.

SECTION VII: ENFORCEMENT AND RETRIBUTION

7.1 *Self-Executing Enforcement.* Contracts shall enforce their own terms without further input or need for external judgment.

7.2 *Retributive Consequences.* Mortals who violate or attempt to void an Infernal Contract shall be subject to punitive measures, including but not limited to:

a) *Eternal Damnation in the Ninth Layer of Hell.*

b) *Immediate and violent spiritual disintegration.*

c) *Soul liquidation and transformation into a lesser infernal form.*



d) *Retroactive expansion of contractual terms.*

7.3 *Binding of Associates.* Mortal associates, direct descendants, and bloodlines may, at the infernal being's discretion, inherit liability for unfulfilled contracts.

SECTION VIII: FINALITY AND SEVERABILITY

8.1 *Finality of Law.* IL-666 represents the ultimate authority on contractual binding and may not be superseded, amended, or repealed by any being other than Asmodeus.

8.2 *Severability.* If any provision of IL-666 is deemed unenforceable, all remaining provisions shall remain in full force and effect.

SECTION IX: RECORD-KEEPING AND DOCUMENTATION

9.1 *Infernal Archives.* All signed Infernal Contracts must be deposited in the Grand Archives of Nessus, where they shall be maintained for eternity.

9.2 *Document Verification.* Any disputes arising regarding contract authenticity shall be resolved by referring to the version stored in the Grand Archives.

9.3 *Auditing of Compliance.* Infernal auditors, appointed by Asmodeus, shall periodically review contracts for compliance and integrity. 9.4 *Archival Security.* Unauthorized access or tampering with the Grand



Archives shall result in immediate soul forfeiture and eternal damnation.

SECTION X: CONTRACTUAL EXPANSION AND INTERPRETATION

10.1 *Interpretation in Favor of the Infernal Being.* Any ambiguity or dispute regarding contract terms shall be resolved in favor of the infernal being.

10.2 *Expansive Interpretation Clause.* Infernal Contracts shall be interpreted expansively to include any implied obligations not explicitly stated.

10.3 *Addendum Integration.* Any addenda or supplementary agreements shall automatically become part of the original contract and enforceable under IL-666.

10.4 *Temporal and Planar Binding.* Contracts shall remain enforceable across all planes, timelines, and alternate realities.

SECTION XI: SUPPRESSION OF MORTAL APPEALS

11.1 *Waiver of Appeals.* Mortal signees forfeit all rights to appeal judgments issued under an Infernal Contract.

11.2 *Denial of Mercy.* Claims for mercy, reprieve, or renegotiation shall not be entertained under any circumstances.



11.3 *Punitive Appeals*: Any mortal signee attempting an appeal in defiance of this law shall face additional punitive measures.

SECTION XII: LEGAL PRECEDENCE AND CONTINUITY

12.1 *Historical Continuity*: IL-666 applies retroactively to all contracts signed since the dawn of the Nine Hells.

12.2 *Precedence over Mortal Laws*: No mortal law, ethical standard, or precedent shall overrule or delay enforcement of an Infernal Contract.

12.3 *Void of Celestial Preemption*: Attempts by celestial beings to preempt or intervene in Infernal Contract enforcement shall be considered an act of war.

INFERNAL AUTHORITY SEAL: This law is hereby enacted under the watchful gaze of Asmodeus, Sealbearer of the Nine Hells.

DATE OF ENACTMENT: Eternal, retroactive to the formation of the Nine Hells.

FOR ENFORCEMENT: All Infernal Contracts are now protected under IL-666 and may invoke its authority in any disputes or enforcement actions.
